Ken stated that everything will be thoroughly vetted through a possible town hall meeting and voted upon by a majority of the governing body (board of trustees appointed at time of vote.) Our attorney will review the final draft ordinances upon completion and will be available to address the process should a town hall meeting be conducted or warranted.
